Purpose and Scope of the Policy

This Privacy Notice outline the personal information that Afro Miaki Group (Pty) Ltd may collect, how Afro Miaki uses and safeguards that information, and with whom we may share it.

This Website Privacy Notice applies to personal information that Afro Miaki Group Pty) Ltd collects through this website www.afromiaki.com it also addresses additional pertinent aspects such as:

1. Direct marketing communications
2. Retention of data
3. Cookies and device data
4. Personal information obtained by way of social media networking
5. Transfer of personal information outside the Republic of South Africa

Definitions

Cookies means a small text file (up to 4KB) created by a website that is stored the user's computer either temporarily for that session only or permanently on the hard disc (persistent cookie). Cookies provide a way for the website to recognize you and keep track of your preferences.

Data means any information in electronic form.

Data Subject means the person to who personal information relates.

IP address means a unique address that identifies a device on the internet or a local network.

Operator refers to a person who processes personal information for a responsible party in terms of an existing contract or mandate, but without coming under the direct authority of the responsible party.

Personal Information takes the meaning ascribed to it in terms of the Protection of Personal Information Act 4 of 2013 and means information relating to an identifiable, living, natural person or, where applicable, an identifiable, existing juristic person.

POPIA means the Protection of Personal Information Act 4 of 2013.

Regulator means the Information Regulator.

Responsible Party in this context refers to Afro Miaki Group (Pty) Ltd which determines the purpose of and means for processing personal information.

Traffic data means any data processed for the purpose of the conveyance of a communication on an electronic communications network in respect of that communication and includes data relating to the routing, duration or time of a communication.

User means a person who uses a computer or other device to access the website.

Web browser means an application used to access and view a website. Well known web browsers include Internet Explorer, Google Chrome and Safari
